On Sunday, September 1<sup>st</sup>, I received the following email from Dean Congbalay ....don't know Dean? You should! He is migrating over from the I/N game. Dean has a charming personality and an infectious laugh. He is responsible for the recent article in the *Enquirer*, "Young Students take up the game of Bridge", and we laughed when we saw the photograph for an accompanying story. Dean and I connived to send it to Jay Leno's "Headline News" segment...we are still looking for it. His email to me read:

***Today was neat.***

***A friend of mine and I traveled to Pinellas Park, FL, for two sessions of a sectional bridge tournament. On the last round of the morning event, our unlikely opponents were two incredibly charming kids who were as gregarious and outgoing as they were smart.***

***The girl was 11. Her father started teaching her bridge five years ago; all of her brothers play, as well. Her partner was a 13-year-old boy who has earned 49.23 master points. He learned the game from his grandmother and has already played in a national tournament. He even plays Two-Over-One.***

***On the penultimate board, she dealt and opened a diamond. He jumped to Blackwood. After she showed one ace, he bid 6NT.***

***My partner smartly cashed in her ace on the first trick. The boy then quickly proceeded to take the next few rounds. In the middle of the hand, he led a small spade. My partner followed low. He called for a low spade from the dummy; she pointed at her 6 and played it only after he muttered "yes" and nodded his head. I then plucked a good 8 from my hand, but just as it was exposed and nary a few inches from the face of the table, he realized his mistake and abruptly called for the dummy's Queen.***

***All of us knew what was happening. Our four sets of eyes darted from one face to another. But nobody called for the director; my very gracious partner gave him a gentle smile and told him that she would allow him to correct his error and play the winning card.***

***I didn't argue. He, of course, took the rest of the tricks and got a high board.***

***As we all put our cards back in the metal tray, my partner looked at me, obviously concerned that her decision annoyed me. "He made a bold bid," she said. "They're nice kids; I didn't want to win that way."***

***There was, however, no reason for her to justify her action. I smiled and immediately assured her that she did the right thing. When the final tallies were in, we perused the score sheet. We came in second place -- trailing the winner by a scant 0.62 point. That one, generous ruling made the whole difference.***

***I can't say enough how proud I was of my partner. I gave her a big hug, and we happily took off for lunch.***

The cover story of this past June's *Bridge Bulletin* told about the latest bridge book surveys. Two top ten lists resulted - the *Experts Favorites* and the *Readers Favorites*. Most of the total 15 favorites (five books showed up on both lists) were already in the CBA library. Also in June's Bulletin was *New Players Reading List* by Tim Bourke, "arguably the world's foremost expert on bridge literature". The library's goal is to eventually include all of the books from these 3 lists on our bookshelves. To that end, most of the new additions recently purchased and listed below came from the lists. The library has also purchased two sets of Audrey Grant videos/dvds. These are two sets of classes - the 3-volume Bridge Brush-up and the 2-volume Bridge at Sea (the 3<sup>rd</sup> volume is no longer available). The Bridge Brush-ups are 13 half-hour PBS programs recorded in the late 90's. The Bridge at Seas, as you might guess, are recordings of classes Audrey has given on cruises. Both sets have great visual aids, top-rated teaching and short sidebars like multiple choices for bridge terms (e.g. what is a Pajama Party?). The ability to use the pause & replay buttons is a big plus.

Another purchase, Audrey Grant's Bridge at a Glance, a 32-page booklet showing the bidding diagram and the bidding ladder with the meaning of all the bids, is displayed on the library's easel. Because of the nature of this item, currently it will NOT BE AVAILABLE FOR LOAN. It will, however, be displayed and available for your review indefinitely. It fits easily inside the Convention Card for quick reference. I purchased one of these for myself. It's the perfect example of one of the best uses of the CBA library - to check out an item to see if it's something to add to your own library.

# The Twilight Zone

This hand cropped up at a recent matchpoint duplicate game. It was the first hand of the day for my partner and me.

My partner, sitting in first seat white vs. white, chose to pass the West hand. North opened 1♣, and I overcalled 1♥. South bid 1♠, and thereafter we were in the Twilight Zone. The next two bids were made rapidly. West came to life with 5♦, and North bid 5♠.

I thought I had a tough call and, after a considerable pause, I passed, and before my partner could bid, North announced that she was barred because of my (admitted) hesitation. I protested this remark by North, the director was called (by me) and the director correctly ruled that West was not "barred" but could not be influenced by my hesitation. West then doubled 5♠, and North passed.

I believed we could not beat 5♠, given this auction, and I corrected to 6♦. South and West passed and, after considerable thought, North bid 6♠ (as she put it "to save"). All passed. So my bidding had succeeded in pushing the opponents to a cold slam.

But wait! My partner led the ♥ Ace, I encouraged, but alas partner returned a spade, being now out of hearts to lead. South (declarer) won the ♣ Ace, drew trumps, and led the ♣ King, on which she deposited her singleton diamond, and West also played a diamond.

As this last trick was in the process of being turned over by all, I uttered these fatal words: "No clubs, partner?" My partner was indeed void, but declarer was not, and proceeded to correct her (revoking) diamond, and take the rest of the tricks -- 6♠ bid and made!

Our opponents on this hand (very competent players) proceeded to finish first overall and win the jackpot. After the game, I requested \$.25 from each of them, as I had contributed at least that much to their win. They gave me two cents! Rod Serling would have been proud.

## **Organization of THE CINCINNATI BRIDGE ASSN.**

On September 17, 1971, The Cincinnati Bridge Association, Unit 124 of the ACBL, filed an application with Ohio to incorporate as a non-profit corporation. The application was approved and the CBA continues to operate under this charter. THE CBA also is recognized by the Internal Revenue Service as a not-for-profit corporation under I.R.C. Section 501(c)(7), Social and Recreation Clubs. The CBA does not pay income taxes except on income from investments and activities unrelated to promoting, playing and teaching bridge. The CBA must, however, file an annual report of revenue and expenses with the IRS.

Every member of the ACBL who lives in the Unit 124 area is automatically a member of the CBA and a small portion of ACBL dues is returned to the CBA. We are also part of ACBL District 11, which includes central and southwest Ohio, plus parts of Indiana, Kentucky, and West Virginia.

The original organizers of the CBA also developed a constitution and by-laws. This has since been amended five times. The Constitution establishes the aims and purposes of the CBA (the promotion of bridge in all its aspects in Cincinnati and the surrounding territory) and the governing structure of the CBA.

The business of the CBA is controlled by the Board of Trustees, consisting of fifteen elected members, plus any ex-officio members; these include the immediate past President and bridge editors for the major Cincinnati newspapers (however, there are no longer any local newspaper bridge editors). Five Trustees are elected each year for a term of three years with every CBA member being eligible for nomination. Election is by secret ballot at the CBA's fall bridge tournament; however, ballots are also available by mail for those who make a request. The Board of Trustees elects officers at its December or January organizational meeting; officers are: President, Vice-President, Executive Secretary, Recording Secretary, and Treasurer. All but the Executive Secretary and Treasurer must be elected Board members. All officer terms are one year.

The seat of any Board member who misses four Board meetings in a calendar year, or who misses three consecutive Board meetings in a calendar year, is automatically vacated and the Board then has the responsibility to elect a replacement Trustee to complete that term. A Trustee can be excused for missing a meeting only because of serious illness or because of a conflict with other official CBA business.

A member of the Board of Trustees is limited to two full consecutive terms but can be elected again after being off the Board for one year. Nevertheless, the Board is given the power to by-pass this rule to elect a replacement Trustee who has left the Board in mid-term.

An executive Committee has the same powers as the Board of Trustees but only in an emergency when the President determines there is insufficient time to call a meeting of the full Board. This Committee is composed of the President, Vice-President, Recording Secretary, Treasurer and three other Board members elected by the Board at its organizational meeting.

Amendments to the Constitution may be proposed by the Board of Trustees, the Executive Committee, or by petition of fifty (50) members of the CBA. Proposed amendments may be adopted by a majority vote of the CBA members present at any regular or special meeting of the CBA.
